### PROGRAM:

Justin Bradshaw introduced Brigadier General Michael D. Wickman to present today's program. General Wickman assumed duties as the Deputy Commanding General - Maneuver, 34th Infantry Division, Minnesota National Guard in 2017 and he is the primary advisor to the Division Commander of Operations. He has served active duty in Operation Iraqi Freedom and Operation Enduring Freedom. He has been awarded the Bronze Star Medal and the Meritorious Service Medal. both with oak leaf clusters, as well as several other commendation and achievement medals. He began his remarks by describing the five priorities of the newly appointed Adjutant General currently being promulgated. They are: People, the Guard's most important assets are its people and they are the best and the brightest soldiers in the world; Leadership, the Guard must develop and continue to grow its leadership; Organizational Safety and Security; world-wide threats are no longer just physical but cyber warfare threatens our safety more than ever; Physical Property; the Guard must meet public expectations of stewardship and protection of resources; Communication; with partners including families, communities and employers.

General Wickman described the challenges of leading today's soldiers, the majority of whom are millennials who have differing values which don't necessarily mesh with the uniformity requirements of the military. They do, however, fit the technology needs well.

As mentors, leaders must present duties in a way of meaning; orders must make sense and have a clear connection to the goal. Both the Guard and its soldiers must adjust to the constant and high speed flow of information from multiple sources. Further, the majority of National Guard recruits are entering without prior active duty and therefore training must be designed to meet their needs and reduce the gap between experience and training. The significant need for training for new technology also presents a significant need to minimize turnover. The General also described the challenges and risks of soldiers possessing smart phones.


