# <u>Program:</u> Berker Tas, White Bear Youth Exchange, Where Are They Now?

In August 2001 Berker Tas was a 17-year-old student from Ankara, Turkey when he arrived in White Bear Lake as our Club's exchange student. Three weeks later, on September 11, 2001, Islamic militant terrorists organized by Osama bin laden attacked the United States by hijacking 4 passenger planes and crashing into the Twin Towers of the World Trade Center, the Pentagon, and a field in Pennsylvania. Being from a Muslim country it became a difficult time for Berk. As he now states, the members of White Bear Rotary befriended him and gave him much peace and comfort. He was so grateful for the Rotary experience that he applied and received a scholarship at the University of St. Thomas, where he played on the basketball team and graduated with a BS Degree in Electrical Engineering and Physics. After graduation, he worked for Boston Scientific. He also received a MBA from the Carlson School of Management. He married in 2009 with a destination wedding in Jamaica attended by several WBL Rotarians. Beginning in 2009 he worked for business start-ups. He accepted a position in England and he and his wife moved to Oxford, England where they lived and worked for 2 years. They subsequently moved back to Minnesota and they and their 2 young children now live in Southwest Minneapolis. Berk is the current CEO and a team leader for SentiAR, an augmented reality company headquartered in St. Louis, Missouri. SentiAR develops a medical 3D augmented reality platform featuring real-time holographic visualization of a patient's actual anatomy. The 3D hologram of the heart improves a physician's efficiency and ability to deliver therapy to the patient for the treatment and analysis of cardiac arrhythmias within an interventional catheter lab environment. Berk, thank you so much for being our exchange student. You have made us all very proud. Please stay in touch.
